The University of International Business and Economics (UIBE), colloquially known as the “Oriental Harvard”, and located in Beijing, China, is one of the leading law schools in China, and offers students the opportunity to study for an LL.M. in Chinese Law in English, along with students from all over the world, including the United States and Europe.



Beijing is China’s capital and offers students an amazing opportunity to explore hundreds of years of Chinese history, visit the Forbidden City and try some of China’s best food. At UIBE, students have the opportunity to develop an expertise in the Chinese legal system, particularly in the area of Chinese business law. Of the course of one year, students will also be able to attend Chinese language classes in order to develop their Chinese

language skills.

Please note that this program is 2 years long (1 year studying; one year writing a 60 page thesis), however, students only have to spend one academic year in Beijing. During the following summer or academic year in Spain, students will have to write a 60 page thesis with the help of a supervisor in Beijing and defend the thesis via Skype.
